THE COUNCIL HELPS OLDER ADULTS AT RISK OF MALNUTRITION AND SOCIAL ISOLATION TO EAT A NUTRITIOUS MEAL AND ENJOY THE COMPANY OF OTHERS THROUGH MEALS ON WHEELS (MOW), CONGREGATE/SENIOR CENTER MEALS, AND FROZEN AND SHELF-STABLE MEALS. IN 2020, COMMUNITY PARTNERS AND VOLUNTEERS DELIVERED MEALS ON WHEELS ON 12 ROUTES THROUGHOUT CHATHAM COUNTY TO HOMEBOUND SENIORS, MANY OF WHOM LIVE ALONE. THE COUNCIL'S TWO SENIOR CENTERS OF EXCELLENCE OFFER A NOON-DAY MEAL AND ACTIVITIES. FOR SENIORS WHO CANNOT ATTEND THE CENTERS AND ARE NOT ON MOW ROUTES, THE COUNCIL OFFERS FROZEN MEALS, WHICH ALSO AVOIDS FOOD WASTAGE. IN ADDITION, THE COUNCIL MAINTAINS A SUPPLY OF SHELF-STABLE MEALS FOR USE IN ADVERSE WEATHER AND OVER HOLIDAYS. IN

4b (Code:) (Expenses \$ 487,073. including grants of \$) (Revenue \$) THE COUNCIL OFFERS AN IN-HOME AIDE (IHA) PERSONAL CARE SERVICE AND RESPITE FOR FAMILY CAREGIVERS USING STATE-LICENSED HOME CARE AGENCIES. THE COUNCIL ARRANGES FOR IN-HOME AIDES TO PROVIDE PERSONAL CARE, MEAL PREPARATION, AND OTHER TASKS THAT FRAIL ELDERLY CANNOT DO FOR THEMSELVES AND THESE AIDES ARE ALSO USED TO OFFER RESPITE TO FAMILY CAREGIVERS. SIMILAR TO ITS NUTRITION SERVICES, THE COUNCIL OFFERS ITS IN-HOME PERSONAL CARE AND RESPITE TO HELP FRAIL ELDERLY REMAIN LIVING SAFELY AT HOME. THE CARE PLAN IS CUSTOMIZED TO EACH PARTICULAR CLIENT'S NEEDS AND FAMILY SUPPORTS. ABOUT 107 SENIORS AND CAREGIVERS WERE ASSISTED THROUGH THIS PROGRAM IN 2020, RECEIVING 24,431 HOURS OF SERVICE. THE TYPICAL IHA CLIENT IS AN 82 YEAR OLD FEMALE WHO LIVES ALONE. AMONG IN-HOME AIDE CLIENTS, 95% SAW THEIR NUTRITIONAL HEALTH

4c (Code:) (Expenses \$ 295,922. including grants of \$) (Revenue \$) THE COUNCIL PROVIDES GENERAL AND MEDICAL TRANSPORTATION SERVICES THROUGH CHATHAM TRANSIT, THE LOCAL COORDINATED SYSTEM WHICH PROMOTES COLLABORATION AND EFFICIENCIES. IN PRE-COVID TIMES, THE COUNCIL ARRANGED FOR THE TRANSPORTATION OF OLDER ADULTS TO ITS TWO SENIOR CENTERS FOR LUNCH AND ACTIVITIES (ON 8 ROUTES THROUGHOUT THE COUNTY), WITH WEEKLY STOPS AT THE GROCERY STORE AND PHARMACY. THIS CHANGED WITH COVID AS THE COUNCIL HAD TO USE CHATHAM TRANSIT TO HELP TAKE MEALS AND SUPPLIES TO SENIORS SHELTERING IN PLACE. THE COUNCIL CONTINUED TO PROVIDE TRIPS TO MEDICAL APPOINTMENTS AND EXPANDED IT TO OTHER ESSENTIAL SERVICES. PRE-COVID, THE COUNCIL ALSO ARRANGED TRIPS FOR OUTINGS (E.G. FARMERS' MARKETS, MUSEUMS). THIS YEAR, 326 SENIORS BENEFITED FROM COA TRANSPORTATION, INCLUDING 155 WHO RECEIVED 2,482
